GENERAL TERMS AND CONDITIONS

for

Social Media Contest “What do YOU think is our NEXT move?”
(hereinafter: Terms)

April 2019

1. ELIGIBILITY

- 1.1 ICONOMI Social Media Contest “What do YOU think is our NEXT move?” is available on the [ICONOMI Facebook page](#) and on the [ICONOMI Twitter page](#) and is organized by ICONOMI Limited, 66 Old Bakery Street, Valletta, VLT 1454, Malta (ICONOMI) (the “Contest”).
- 1.2. The Contest is available to all natural persons who are existing users of Facebook and/or Twitter.
- 1.3 Employees of ICONOMI, its affiliates and employees, affiliates and employees of subsidiaries and/or companies cooperating with ICONOMI are not allowed to enter the Contest.

2. PARTICIPATION

- 2.1 Each entrant may enter the Contest by answering the question “What do YOU think is our NEXT move?” in the comment under the Contest post on ICONOMI Facebook page and/or on ICONOMI Twitter page. All answers/comments related to the Contest’s question are acceptable except those who do not meet the conditions from the next point of these Terms.
- 2.2. By entering, entrants represent and warrant that their answer/comment does not present and/or include any vulgar or offensive words or expressions. No such answers/comments (as determined by ICONOMI in its sole and absolute discretion) will be accepted. ICONOMI reserves the right in its sole and absolute discretion to disqualify any entry and/or delete such answer/comment.

- 2.3. The Contest starts on April 8, 2019 and entrants shall successfully and validly enter the Contest in accordance with the point 2.1. of these Terms by April 10, 2019 at 12:00 CET.
- 2.5. No purchase is necessary to enter the Contest. Only one entry per person shall be accepted. Inappropriate and/or multiple entries, answers or comments will not be accepted. ICONOMI reserves the right to reject any enters, posts, answers, or comments for any reason at its sole discretion.

3. WINNERS AND REWARDS

- 3.1 Each entrant who successfully complete the conditions from point 2.1. of these Terms will be entered into the computer system, which will be used for the drawing in accordance with these Terms (e.g. software random generator or electronic drawer).
- 3.2. Entrants with the participation in the Contest compete for the following rewards:
 - Reward for the Contest on ICONOMI Facebook page: ICONOMI cap and ICONOMI hoodie and
 - Reward for the Contest on ICONOMI Twitter page: ICONOMI cap and ICONOMI hoodie;(the “reward”).
- 3.3. The recipients of the reward from the previous point of these Terms will be determined among all entrants by drawing using the computer system (the “winner”). The winner will receive the reward. The result of the draw is final. The same entrant cannot receive the reward within the Contest on ICONOMI Facebook page and the reward within the Contest on ICONOMI Twitter page. Only one reward per entrant is possible.
- 3.4. The draw will take place on April 10, 2019 at 14:00 CET in the presence of the three-member commission. The commission is composed of three members, appointed by the decision of the legal representatives of the organizer. The commission has the competence to control the running of the Contest and drawing the winners in accordance with these Terms. The minutes of the drawing must be signed by all members of the commission.
- 3.5. ICONOMI will publish the winners within its campaign on ICONOMI Facebook page (for a winner of the Contest on ICONOMI Facebook page) and within its campaign on ICONOMI Twitter page (for a winner of the Contest on ICONOMI Twitter page).
- 3.6. The winners from the previous point will be notified about the received reward:

- For the Contest on ICONOMI Facebook page: By Facebook private message and with the mention of the winner on ICONOMI Facebook page;
 - For the Contest on ICONOMI Twitter page: By Twitter private message and/or with the mention of the winner on ICONOMI Twitter page.
- 3.7. Before claiming the reward, winners will be asked for their name, address, and any other relevant information necessary for ICONOMI to be able to send and/or award the reward. ICONOMI will process these personal data solely for the purpose of sending and/or awarding the reward to the winners.
- 3.8. If a winner cannot be notified about the reward within 10 days or does not timely (i.e. within 15 days after notification) provide his/her data for the purpose of sending and/or awarding the reward, then the reward will be forfeited, and the reward will not be awarded.
- 3.9. There will be no substitutions or cash alternatives for a reward except at the sole discretion of ICONOMI. ICONOMI has the right to substitute a reward of similar value. No transfer or assignment of reward is allowed.
- 3.10. In claiming your reward, you acknowledge that ICONOMI has the right to publicize your name, surname, likeness, photograph and the fact that you are the winner for promotional purposes without financial remuneration.

- 6.2 In case of fraud, virus, bug, catastrophic event, or any other unforeseen or unexpected event that cannot be reasonably anticipated or controlled (also referred to as force majeure) affects the fairness and/or integrity of the Contest, ICONOMI reserves the right to cancel, change, or suspend the Contest. ICONOMI reserves the right to draw the winners from among all eligible entries received before the cancellation, change, or suspension of the Contest.
- 6.3 This Contest is subject to all applicable laws and regulations and is void where prohibited. Each winner is solely responsible for any possible applicable taxes related to accepting the Contest reward.
