GENERAL TERMS AND CONDITIONS

for

Social Media Contest “Welcome New Users”

(hereinafter: Terms)

January 8, 2020

1. ELIGIBILITY

- 1.1 ICONOMI Social Media Contest “Welcome New Users” is available on the ICONOMI Facebook page, on the ICONOMI Twitter page, on Quora website, Reddit website, Google ads and on Gmail ads and is organized by ICONOMI Limited, 10 Orange Street, London, WC2H 7DQ, United Kingdom (ICONOMI) (the “Contest”).
- 1.2. The Contest is available to natural persons who are residents of one of the European Union member states, are eligible for creating an account on the ICONOMI platform and do not have an open account on the ICONOMI platform at the beginning of the Contest (i.e. only new users).
- 1.3 Employees of ICONOMI, its affiliates and employees, affiliates and employees of subsidiaries and/or companies cooperating with ICONOMI are not allowed to enter the Contest.

2. PARTICIPATION

- 2.1 Each entrant may enter the Contest with registration on the ICONOMI platform (i.e. opening an account) following by successfully and validly completed Tier 1.2 verification level (i.e. providing personal data, ID document and proof of address);

The registration on the ICONOMI platform must be completed by the entrant during the Contest period as determined in point 2.2. of these Terms, wherein the verification must be completed no later than two business days after the completed registration. If the entrant does not successfully, validly and timely complete all required steps under this point and/or already has an opened account on the ICONOMI platform at the beginning of the Contest, the entrant is not able to participate in the

Contest and is not entitled to receive the reward from point 3.1. of these Terms.

- 2.2. The Contest runs from January 8, 2020 until January 31, 2020 at 23:59 UTC. Notwithstanding the previous sentence, ICONOMI has its sole discretion to shorten or extend the Contest period.
- 2.3. Only one entry per person will be accepted. Inappropriate and/or multiple entries will not be accepted. ICONOMI reserves the right to reject any enters for any reason at its sole discretion. In case of any fraudulent activity or any other activity which is non-compliance with these Terms and/or is inconsistent with the purpose of this Contest, ICONOMI reserves the right in its sole and absolute discretion to disqualify any entry and/or delete any entrant's account.

3. WINNERS AND REWARDS

- 3.1 Each entrant who successfully completes the conditions from point 2.1. of these Terms (the "winner") will be entitled to receive a deposit of Ether (ETH) or Bitcoin (BTC) in the value of 10.00 EUR (the "reward").
- 3.2. The deposit will be made directly to the winner's account on the ICONOMI platform not later than in seven (7) business days after the completion of the Contest period.
- 3.3 The Ether or Bitcoin deposit amount from the previous point will be calculated on the basis of the average ETH/EUR or BTC/EUR market price on the day before the deposit will be credited to the entrant's account on the ICONOMI platform.
- 3.3. The same entrant cannot receive more than one reward within the Contest. Only one reward per entrant is possible.
- 3.4. The winners will be notified about the received reward via email after the reward will be credited to their account on the ICONOMI platform. ICONOMI will process entrants' and/or winners' personal data solely for the purpose of organizing the Contest and/or awarding the reward to the winners.
- 3.5. There will be no substitutions or cash alternatives for a reward except at the sole discretion of ICONOMI. ICONOMI has the right to substitute a reward of similar value. No transfer or assignment of reward is allowed.

- 4.1 ICONOMI takes no responsibility for any entries that are lost, delayed, illegible, corrupted, damaged, incomplete, or otherwise invalid. Such entries will not be accepted.

Contest. ICONOMI reserves the right to award the entrants from among all eligible entries received before the cancellation, change, or suspension of the Contest.
